Rules and Regulations

1st Place Prize \$1,000.00 -- 2nd Place Prize \$600.00 -- 3rd Place Prize \$400.00

1. Registration Entry Fee is **\$110.00** for each performance, for a three **(3)** minute **maximum time performance**.
2. There is no limit on entries of any group registration as long as the \$110.00 fee and registration are completed for each performance wishing to enter.
3. Registration Entry forms may be **downloaded on line at @ <http://anaheim5demayofiesta.com/ballet-folklorio/>**
4. Space will be limited to the first 35 teams and is open to the public and any Ballet Team/Group.
5. Registration and paid entry must be received no later than April 30, 2017 at 5:00PM or earlier if the 35 team limit has been reached before that date and time.
6. Any entries submitted or unpaid after April 30, 2017 @ 5:00PM will not be considered for entry to the event.
7. All music choices will have to be submitted in MP3 format with your application and a back up copy of the music must be brought with you on the day of the event.
8. Any changes must be submitted no later than April 30, 2017 @ 5:00PM. **NO EXCEPTIONS**
9. There will be a three (3) minute time limit to all performances, anyone going over will be deducted points
10. Judges will be looking for the following criteria: 1. Stage Presents, 2. Synchronization, 3. Costume Creativity
11. The Judges decisions will be FINAL. **NO EXCEPTIONS!!!**
12. **The winners will be announced at the end of the event, and will be expected to perform on Sunday May 7th at the dignitary Breakfast at 10:00AM at which time they will be presented with their Prize Check.**
13. This is a family event. There is NO Alcohol, Drugs or Smoking Allowed.
14. All teams are expected to be respectful to all other participants. Disrespecting, including mocking, bullying, or rude remarks may disqualify your entire group.

This should be a positive experience for everyone.
15. The maximum amount of dancers will be 10 per group on the stage at one time.
16. All performance times will be given out at **8:00 AM at check-in time** on April 6, 2017 near the front of the stage.
17. **Competition begins at 9:00AM and ends around 12:00Noon.**
